Call to Order:

The meeting was called to order by Chairman, Chris Bauserman, at 9:33 AM. The Pledge of Allegiance was led by Engineer Bauserman.

1. HYATTS AND U.S. 23 ROAD AND SANITARY IMPROVEMENTS

County Engineer and Regional Sewer District staff have finalized the bidding documents and project agreement for a combined roadway and sanitary sewer improvement at Hyatts Road and US 23 to be undertaken by the DCTID.

The roadway improvements include widening of Hyatts Road and Shanahan Road approaches to US 23 to provide for turn lanes, and includes replacement of culverts and constructing headwalls for a large 96-inch diameter pipe culvert under Hyatts Road just west of US 23 to allow for the widening.

The sanitary sewer improvements include constructing a new pump station west about 500 feet west of US 23 on the north side of Hyatts Road, and constructing gravity sewers to the east, passing under US

23 and serving the area from Shanahan Road to Peachblow Road east of US 23. Sewage would be pumped west to existing gravity sewers farther west on Hyatts Road, ultimately to the Olentangy Environmental Control Center (OECC) treatment plant.

Total construction cost is estimated at **\$6.2 million**, including construction of water lines, which would be reimbursed by Del-Co Water Company, Inc. pursuant to separate agreement.

Proposed project schedule would be as follows:

1/8/2020: DCTID board approval of plans, specifications, estimates and the project agreement with Delaware County Board of Commissioners

1/10/2020: Advertisement for bids

2/4/2020: Bid opening

2/12/2020: Contract award by DCTID

12/1/2020: Road construction complete

3/1/2021: Sewer construction (including pump station) complete

2. 2020 BUDGET

A draft budget is enclosed for the TID's consideration.

The capital fund budget includes appropriations totaling \$18.1 million for current and planned projects in 2020 as well as \$16,000 for general fund expenses to pay for accounting services and any general supplies that are needed by the TID.

Other Comments:

The North Road Improvements will be a public/private combination up to Peachblow Road. The new road will be used by the proposed new elementary school (Olentangy Local School District) in 2021. The bond that will be used to build that school is on the ballot in March, 2020.
