## Staff Report:

#### March/April 2020

#### 1. HOME ROAD EXTENSION EAST OF U.S. 23

Nickolas Savko Inc. continues work on the sanitary sewer and earthwork on the Home Road Extension. Sanitary sewer is about 75% complete. Earthwork is less than halfway complete.

Completion of the segment of road from U.S. 23 to the Orange Grand development entrance is still projected to be complete by fall 2020; however, it is expected that the completion of the project will be pushed to spring 2021 due to expected delays on some specialty work due to COVID-19 and the wet spring weather.

## 2. HYATTS ROAD AND U.S. 23 IMPROVEMENTS

Complete General Construction is planning on beginning work on the sanitary sewer construction in April. Road work is still scheduled to be complete by November 2020 and sanitary work by January 2021.

As part of the project, Del-Co Water Company has requested the TID relocate the water lines in the work limits which are in conflict with the project work. The agreement specifies that the actual cost of the work will be reimbursed by Del-Co.

## 3. RIVERBY ESTATES IMPROVEMENTS

Strawser Paving will begin work on the entrance improvements at Riverby the week of April 6. Paving work will begin when asphalt plans are opened in May. Completion is expected by July. It is expected that the schedule of special assessments will be finalized at the August 12<sup>th</sup> TID Board Meeting.

#### 4. GRAPHICS WAY EXTENSION (ORANGEPOINT TO MENARDS CREEKSIDE)

The County Engineer's Office has completed plans, specifications, and estimates for this project. As previously outlined, the project will be paid for by Delaware County pursuant to a project agreement and will involve a special assessment levied by the Board of Commissioners on the Lifepoint Church to recoup up to \$250,000 of the total project. The project agreement follows the standard form and will include a cash deposit of \$600,000 by the County. The estimated construction contract cost of the project is \$560,000 including a \$50,000 encumbrance for change orders and contingencies. The administrative fee to be collected by the TID is estimated at \$16,200.

#### 5. ODOT TID GRANT PROGRAM

DCEO staff received notice from the ODOT Division of Jobs and Commerce that applications for the SFY 2021 TID Grant program will be open until May 31, 2020. Staff recommends submitting a \$250,000 grant application for the North Road Extension, Phase 2, which will construct about 0.4 miles of new roadway from Peachblow Road south toward Shanahan Road.

This phase will serve the proposed new Olentangy Elementary School and will serve as another segment in the planned parallel road network along U.S. 23. The need for this project is supported by the U.S. 23 Corridor Study that was completed by the Delaware One group in 2019.
